The purpose of the Completions Operations Supervisor is to supervise a team of Completion and Subsea engineers and is responsible for the provision of engineering technical support for well planning, operations and performance monitoring. The Completions Operations Supervisor will be the focal point for all current and future in-country Completion/Testing/Subsea activities and well planning.

Responsibilities/ Key Objectives

- . Responsible for completion and DST operational improvement in Ghana Deepwater.
- . Ensures EHS requirements are integral to all aspects of completion, well testing and well intervention activities.
- . Contribute to delivering operational EHS performance.
- . Lead by example during rig visits and foster a solid EHS culture.
- . Ensures that all completion activities comply with company standards and governmental regulations.
- . Provides completions input to team and well engineering delivery objectives as necessary.
- . Responsible for the specification of completion, well testing and well intervention related equipment and services in accordance with company procedures.
- . Ensures that all work within the area of responsibility is adequately documented and lessons learned are closed out for the benefit of future Tullow operations worldwide.
- . Ensure well material and service providers comply with specified quality assurance requirements.
- . Build effective relationships and interact professionally with internal and external stakeholders and service companies.
- . Assist in the management of the service contracts and contractor performance process.
- . Provide on-time well engineering services which represent best industry practice.
- . Responsible for the provision of all management reporting requirements.

Specific Responsibilities & Key Measures

- . Continuous Improvement
- . Overall responsibility for continuous improvement in well planning, costing and operations for one or more rigs.
- . Maintain completion and testing action tracker incorporating Lessons Learnt and After-Action Reviews.
- . Measure, monitor and benchmark completions and testing performance indicators.
- . Primary focal point for closing out actions in the action tracker.
- . Manage procedure and close outs.
- . Focal point for bi-weekly contractor meetings.

Operational Support

- . Remains in touch with daily operations to ensure full understanding of issues, operational problems, cost, etc.
- . Provides operational input to completion, testing and well intervention activities as required to the Completions Operations Engineer.
- . Plans for future wells and ensures required materials and services are available in country and allocated as required.
- . Conduct specialist projects from time to time, particularly in relation to completion optimisation and or reduction in well cost.
- . Ensures that the appropriate procedures and technical information is in place and up to date.

Risk Management

- . Manage well operation hazard assessments.
- . Prepare and maintain well risk register.
- . Perform and manage well barrier review.

Financial

- . Manage cost estimation and cost control activities.
- . Approves cost estimates for completion, testing and well intervention activities.
- . Approves requisitions and sole source justification.

- Minimum 5 years spent on the rig
